**Advisory – Termination of Voyage at Jeddah / Suspension of Onward
Service to Alexandria**

Dear Valued Customer,

Good day.

We refer to the subject bookings and the current operational situation affecting services through the Red Sea region.

Due to the ongoing security situation and disruption to shipping routes in the Red Sea, all vessel operators have invoked Force Majeure provisions and have either suspended, cancelled, deferred or otherwise altered their respective services until further notice.

Consequently, voyages presently operating through the region are being terminated at Jeddah, Saudi Arabia, which shall be treated as the end of the respective voyage. Accordingly, cargo originally booked for onward carriage to Alexandria, Egypt, cannot be carried to its intended destination under the existing service arrangements.

The availability of vessels and continuation of scheduled services beyond Jeddah remain uncertain and no definite timeline can presently be provided for the resumption of onward services to Alexandria or other destinations beyond Jeddah.

Accordingly, Jeddah shall be considered the final destination and end of voyage under Hikaru Shipping Line FZCO's scope and responsibility for the subject bookings. Any and all arrangements, operations, transportation or other activities required onward from Jeddah to Alexandria, including but not limited to transshipment, connecting vessel arrangements, feeder services, inland transportation, storage, handling, customs formalities, documentation, delivery arrangements and any other related requirements shall be outside the scope of Hikaru Shipping Line FZCO and shall be arranged and undertaken by the Customer at the Customer's sole cost, risk and responsibility.

All costs, charges, expenses, liabilities, risks and consequences arising in connection with any such onward arrangements from Jeddah, including but not limited to port, terminal, storage, detention/demurrage, handling, transshipment, agency, customs, documentation and transportation charges shall be solely for the Customer's account.
